1. Permits, Change, Transfer, Renewal, Sale

The permittee has two amendments for review with the Division. They are "North Lease Water Reductions" reviewed by July 9th, and "Easement Increase schedule for review July 13th.

2. Signs and Markers

The identification sign was inspected and it meets the requirements of the R645 Coal Rules. See Photo

3. Topsoil

The topsoil piles were snow covered. It is unlikely that wind or water erosion has occurred since the piles are well vegetated. See Photos

4.a Hydrologic Balance: Diversions

The diversions and culverts were open and would functioning during a rainstorm. Sediment has started to fill within these structures. The permittee had cleaned out several diversions since the last inspection. See Photos

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment pond at Winter Quarters. The mine was discharging water at 1,200 gal/ mins. The permittee had taken a sample of "Total Iron". The sample tested to be was .80 milligram per liter. The discharge area showed no signs of erosion. The grass was still in place since the last inspection. All other sediment ponds were not discharging. The permittee has plan on cleaning out the mine site sediment pond this summer. Currently, the pond is in the process of getting dry out.

8. Noncoal Waste

The site was clean of non-coal waste materials such as trash, oil cans, wood and scrap materials.

10. Slides and Other Damage

No slides or other damage was notice during the inspection. The mine site and loadout appear to be stable.

16.a Roads: Construction, Maintenance, Surfacing

The roads were compacted with no dust control problem.

16.b Roads: Drainage Controls

I inspected the road diversions and culverts throughout the property. They were open and would function during a rainstorm.

18. Support Facilities, Utility Installations

No new facilities constructed since the last inspection.
