Dear Mr. Bogdin:

Our records indicate we initiated a bill to your company at the above address on 07/28/88 as the result of a compliance audit, finding you had underreported AML fees. A second notice requesting payment was initiated on 08/28/88. Please be advised that failure to make payment will result in referral of your account to our Division of Debt Management for appropriate legal action or further referral to a collection agency. This delinquency has resulted in the initiation of action for future permit denial and present permit suspension. Your account is also subject to any collection or legal costs incurred incidental to the collection action.

Interest is accruing on your delinquent account for every month or part thereof at a rate of 7.000% per annum. Also, a 6 percent per annum penalty will be applied on the principal amount of all debts 91 days past due. The penalty will be calculated back to the initial date of the delinquency and will be applied on the 91st day to your outstanding debt.

This action is required in accordance with the provisions of the Debt Collection Act of 1982, Public Law 97-365.

In summary, full and timely payment of all reclamation fees when due will result in considerable savings by avoiding the assessment of penalties, collection costs and further interest. Your prompt response in this matter will result in our organization providing better assistance to you and the general public.
