General Comments Conducted a partial inspection of the Stopout mine. The mine was snow covered and only conducted an inspection of the coal silt/train loadout disturbed area.

Drainage Drainage culverts and beams were in place and functional.

Sediment Pond Pond #9 contained runoff and showed no evidence of recent discharge.

Other Sediment Control Silt fences on the pad outslope BICA area were observed and no problems noted.

Other redundant silt fences were observed in the train loadout area and were all functional.

Disturbed Markers Required disturbed markers were in place.
