The operator has performed pre winter/spring maintenance work. This was being done at this time in order to minimize the need for maintenance during the winter or spring.

Signs and Markers No signs and disturbed markers were observed.

Drainages Since the last inspection the operator has performed maintenance of a preventative nature. This included upgrading the riprap, minor regrading, berming and culvert maintenance.

Sediment Ponds Observed pond 2 and 9. Both ponds contained runoff and were not discharging.

Roads The primary mine roads had been maintained and snow removed.
