There are no UPDES sampling points at Star Point.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

No slides were noticed during the inspection.

12. Backfilling And Grading

The mine has been backfilled and graded.

13. Revegetation

Star Point has been completely re-seeded.
