1. Permits, Change, Transfer, Renewal, Sale

3. Topsoil

All topsoil was used for reclamation.

4.a Hydrologic Balance: Diversions

The diversion at the lower pad area were open with no snow. The diversions were open and would function during a rain storm. No erosion was noticed during the inspection. The mine pad area diversions were snow covered.

4.c Hydrologic Balance: Other Sediment Control Measures

The complete site is pocked to prevent sediment from leaving the reclaimed area.

8. Noncoal Waste

The site was clear of non-coal waste.

10. Slides and Other Damage

No slides were noticed during the inspection.

12. Backfilling And Grading

The site is completely backfilled and graded to AOC.

16.a Roads: Construction, Maintenance, Surfacing

The County road is snow covered and could not travel to the upper benches.
