1. Permits, Change, Transfer, Renewal, Sale

No amendments have been submitted to the Division.

2. Signs and Markers

The identification sign along the road was inspected and meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

All topsoil was used for reclamation of the mine site. This site used barrow areas for topsoil. This site was a pre-law site.

4.a Hydrologic Balance: Diversions

I inspected the lower diversion where bathhouse and wash plant were located. These diversions were snow covered. There were no signs of water flow within the diversions. These diversions meet performance standards. There were no signs of erosion within the diversions.

4.c Hydrologic Balance: Other Sediment Control Measures

The reclamation site is completely pocked to prevent sediment to runoff site. I did not see any sediment running off site now and prior inspections.

8. Noncoal Waste

The site was clear on non-coal waste materials.

10. Slides and Other Damage

I did not see any slides during the inspection. The site appears to be stable.

12. Backfilling And Grading

It is my opinion that this site even with steep slopes meets AOC requirements.

18. Support Facilities, Utility Installations

There are no support facilities at Star Point Mine. All buildings have been reclaimed.
