1. Permits, Change, Transfer, Renewal, Sale

The US Forest Service and James Owen from the Division of Oil, Gas and Mining inspected the two remote break outs on June 20, 2013. They approved these two sites for Phase III bond release.

2. Signs and Markers

The identification sign is next to the road to the site. The sign meets the minimum requirements of the R645 Coal Rules. The permittee has removed the subsidence markers from the permit area.

4.a Hydrologic Balance: Diversions

All diversions were open and would function during a storm event. The diversions were also inspected during Phase III bond release inspection with no one having any concerns.
