Re: NPDES Discharge Point 015  
Sunnyside Mines, ACT/007/007

Kaiser Coal has applied for and received approval from the EPA to discharge mine water at Discharge Point 015 (see attached letter and map-- EPA to Kaiser, 12-3-86). The water discharged will be from the mine surface storage tanks and is currently discharged through Point 004.

The new discharge point will be via a six- or eight-inch pipe into No. 2 Canyon wash. Erosion control in the wash will be provided by discharging inside the 10-foot diameter CMP underneath the refuse haul road.

This matter has previously been discussed with Mr. Jim Fricke of your office. An early response to this request for permit modification is desired so that this discharge may be activated Friday, December 19.

In your letter dated November 4, 1986, you requested that a new discharge point be designated 006. Our records show that as of August 2, 1985, you had Outfalls 001 through 014 designated. (see enclosed letter). We have designated your new discharge point as Outfall 015 and have enclosed one of your maps with the Outfalls marked as we understand them. We will consider this map with Outfalls 001 through 015 as the November 26, 1986 Revised Area Map submitted pursuant to Part III, A.1 of your permit. A copy has been placed in the permit file.
