Notice of Automatic Stay to the Debtor(s), Debtor's Creditors
and Other Parties of Interest.

Please note that this Notice indicates that as a result
of Kaiser Coal Corporation and Kaiser Steel Corporation having
filed a petition for relief under 11 U.S.C., Chapter 11, certain
acts and proceedings against the debtors and their property are
stayed as provided in 11 U.S.C. § 362(a).

As we discussed in our meeting with you and the Utah
Division of Oil, Gas & Mining on April 14, 1987, it is the
position of Kaiser Coal Corporation and Kaiser Steel Corporation
that the automatic stay applies to the \$8.7 million reclamation
bond requested by the Division in a letter dated March 25, 1987.
The State of Utah may want to file a proof of claim for this
amount with the Clerk of the Bankruptcy Court as discussed in
the enclosed Notice.
