OF DEBTOR'S MOTION FOR AUTHORITY TO SELL PROPERTY

TO ALL PARTIES IN INTEREST:


NOTICE IS HEREBY GIVEN that the movant named below has applied to this Court or is intending to take action as follows: The Debtor has applied to the Court for an order authorizing the following sales of personal property free and clear of the interests of any entities other than the estate: (1) Sale to Mining Equipment, Inc. of an Eimco Diesel locomotive, a Goodman Trolley locomotive, 3 Wagner UT45 underground trucks, 30 supply cars, 30 muck cars, and 4 Joy fans, for \$48,500; (2) Sale to Pittsburg & Midway Coal Mining Co. of a H&B 880 mm taildrive, H&B 880 mm A.F.C. taildrive connector pans, specials and transition pans, 6 H&B panline sections, a Jhanel KST-10 stageloader speed reducer, and a Jhanel 160-BR crusher speed reducer, for \$33,300; and (3) Sale to Co-Op Mining Co. of a Joy 12CM5 continuous miner for \$12,000. A copy of the pleading is available for inspection in the Bankruptcy Court Clerk's Office, or upon request from the undersigned attorney.

Pursuant to Rule 202 of the Local Rules of Bankruptcy Procedure, if you desire to oppose this action you must file a written objection and request for a hearing with the Court on or before May 9, 1994, and serve a copy thereof on the undersigned attorney. Objections and requests for hearing shall clearly specify the grounds upon which they are based, including the citation of supporting legal authority, if any. General objections will not be considered by the Court.

In the absence of a timely and substantiated objection and request for hearing by an interested party, the court may approve or grant the aforementioned application without any further notice to creditors or other interested parties.
