
Sunnyside Coal Company is notifying the Division in accordance with the regulation R645-301-515.300 that a cessation of coal mining operations has occurred.

All surface access openings are being maintained and supported, and the surface facilities are secured. All of the provisions of the approved permit will be kept in compliance. Roads and sediment control structures will be maintained. Monitoring will be performed as scheduled.

It is expected that this cessation of production will extend 30 days with the intention of permanently ceasing production. The required notification in accordance with the provisions of regulations R645-301-515.320 and .321 is being prepared.


