Dear Mr. Edwards:

The Utah Division of Oil, Gas and Mining (UDOGM) and the federal Office of Surface Mining (OSM) are charged with the responsibility to approve the above-referenced project. Pursuant to Title V, Section 510(b)(5) of Public Law 95-87 and Section 13, Chapter 10 of Title 40, Utah Code Annotated, 1953 (40-10-13), the UDOGM has requested the assistance of the Soil Conservation Service and the Utah State University County Agent to assist by making a recommendation to the UDOGM and OSM of whether or not: "the farming that will be interrupted, discontinued or precluded by the above-referenced project is of such small acreage as to be of negligible impact on the farm's agricultural production.


Eureka Energy intends to make use of their water rights on Soldier Creek during the first few years of mining, and thereby the cultivated lands leased by Eureka to John Malleras may not have irrigation water.
