1. Permit -

- a) The Division has approved a permit transfer of the Wellington Preparation Plant to Nevada Investment Company with the resident agent being R. Jay Marshall of Genwal Coal Company. The transfer was approved on May 10, 1994.
- b) The first quarter pond inspection was on March 17, 1994 which is P.E. certified with no hazardous conditions existing.
- c) The first quarter refuse piles inspection was inspected on March 17, 1994 by a certified engineer. There were no hazardous conditions reported.
- d) Wellington Prep Plant has eight surface and fourteen ground water sampling sites in the MRP. The sampling was taken for first quarter and reviewed with all parameters taken as required.
- e) The UPDES self monitoring was taken for first quarter with no discharging occurring. The permit became effective on July 1, 1993 and will expire on April 30, 1998.
- f) The insurance policy 3710-39-89 will expire on January 1, 1995. The policy meets the requirements on the R-645 regulations.
- g) MSHA ponds have been inspected as required. The documents have been reviewed with no hazardous conditions noted.

2. Signs and Markers -

New identification signs have been ordered by permittee and will be installed when shipped by vendor.

4a. Diversions -

The diversions were inspected with no signs of breaching or erosion. These diversions normally are dry until the late August rains.


