Dear Mr. Watson:

On August 8, 1996, an informal hearing was held before the Division to review the fact of violation on state violations N96-46-1-1 and N96-46-2-1. A Findings, Conclusions, and Order determination was signed by Jim Carter on September 24, 1996. In that document it states, "The Petitioner may appeal these determinations of fact of violation to the Board of Oil, Gas and Mining by filing said appeal within 30 days of the date of this Order, in accordance with statutory and regulatory requirements, including placing the assessed civil penalty in escrow."

A Petition for Review and Request for Hearing was filed with the Secretary of the Board on October 9, 1996 for both violations, N96-46-1-1 and N96-46-2-1. At this time the Division has not received escrow amounts for either violation. The amount assessed for N96-46-1-1 is \$200 and N96-46-2-1 is \$440. Failure to comply with this requirement may result in a waiver of your right of further recourse.



