Allen Miller of OSM's Kansas City office asked me about how much coal Hiawatha Coal Company has sold. He is concerned about payment of AML fees. According to Mr. Reynolds, Hiawatha sold about 800 tons of coal in 1997 but none in 1998. This agrees with OSM's records. Some coal fines have been stockpiled near pond 1, and trucks were being loaded during the inspection.


20. Air Quality Permit
