Effective July 1, 1998, the Bureau of Land Management approved the transfer of leases SL-025431, SL-069985, U-026583-058261, and U-51923 from U. S. Fuel Company to Hiawatha Coal Company. This is substantiated in a decision document from the Bureau of Land management dated June 8, 1998, and included in the application. Since the official transfer is now complete, Hiawatha Coal Company, the applicant, is proposing to remove language in the text of the mining and reclamation plan referring to the pending transfer. 
