1. Permits, Change, Transfer, Renewal, Sale

There are no amendments pending. The permittee is planning to permit and develop portals in the Morhland area and possibly use the old Morhland loadout to process and transport coal. It is anticipated that mining of the tank seam in Bear canyon will eventually result in portal development in the Morhland area.
