4.a Hydrologic Balance: Diversions

The culverts at the RR crossing below the #1 slurry pond were inspected. The culverts owned by the Railroad was partially blocked at both ends. As a suggestion it seemed logical to maintain this culvert to some degree in order to maintain the integrity of the other culvert.
