

INVITATION TO BID

Carbon County will accept sealed bids for concrete mow and fencing strip at the ballfields located at the Carbon County Fairgrounds southwest of Price, Utah. The bids are due at the Carbon County Clerk's Office at 120 East Main Street, Price, Utah 84501, prior to 12:00 noon on Thursday, September 2, 2004. Bid opening will be before 5 PM on September 2, 2004. Please note on the outside of the envelope "SEALED BID FOR BALLFIELDS CONCRETE MOW AND FENCING STRIP" in red. Carbon County is not responsible for bids that are received late due to delays in delivery by any source. Faxed bids are not accepted. Carbon County reserves the right to reject any and all bids, to waive any informality of any bid and to select the bid which in the opinion of the County provides the best product, warranty and service to the County. The work will consist of providing material and work to install 30" wide by 6" thick concrete mow strip with rebar, weld plates and compacted untreated base course around the perimeter of the ballfields and parallel with the foul lines. The weld plates will be spaced on eight foot centers. The concrete and weld plates will be enlarged at the end of fences and for gate posts. The project specifications will meet the requirements of the Utah Department of Transportation standard specifications and standard plans where applicable. PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO SOLICIT PUBLIC COMMENT REGARDING THE STATE OF UTAH'S INTENTION TO RENEW A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER QUALITY ACT, SECTION 19-5-104 AND 107, UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO UPDES PERMIT AND THE STATEMENT OF BASIS. (INCLUDING THE TOTAL MAXIMUM DAILY LOADS (TMDL'S), IF APPLICABLE, AS PER SECTION 303 (d) OF THE FEDERAL CLEAN WATER ACT (CWA).
