1. Permits, Change, Transfer, Renewal, Sale

The development of the Morland Portals and permitting options were discussed with Mr. Reynolds. Mining the tank seam in the Bear Canyon mine is expected to break out in the canyon above the old Morland loadout some time in the next two years. The LMU, (Logical Mining Unit), for the area is assigned to Co-op Mining Co. Hiawatha Coal Co's. Permit boundary would include the proposed surface disturbance but not the leases. However, Hiawatha Coal Co. may do the permitting since the expansion would meet the less than the 15% IBC criteria. Permitting options will be discussed further at the on-site midterm review meeting on January 4, 2004 at the Hiawatha offices.

2. Signs and Markers

Signs containing the required information were posted at access points to the property.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The proposed surface facilities would require a sediment pond type of structure.
