There are no pending amendments. The DOGM permit was issued on March 14, 2002 and expires on March 14, 2007.

2. Signs and Markers

Signs with the required information were posted at points of access to the mine complex. There was approximately 10" of snow at the Town of Hiawatha.

18. Support Facilities, Utility Installations

The support facilities at the King 4 & 5 portals were inspected. The area was covered with approximately 18" of snow. The road to this site is plowed during the winter months to facilitate the logging operations above the King 4 & 5 portals.
