1. Permits, Change, Transfer, Renewal, Sale

The DOGM permit was issued on March 14, 2002 and expires on March 14, 2007.

2. Signs and Markers

Signs containing the required information were posted at points of access to the mining facilities. At the time of this inspection, all points of access to the Hiawatha complex were open.

4.a Hydrologic Balance: Diversions

Recent storms have partially filled the culvert by the RR tracks with coal fines. Mr. Reynolds was asked to remove the fines prior to the next inspection. The culvert is oversized and is still functional.

7. Coal Mine Waste, Refuse Piles, Impoundments

Slurry from the #1 slurry pond is being excavated by front end loader and semi tractor trailer. No activity was noted at the time of this inspection as recent storms had made the site inaccessible.
