1. Permits, Change, Transfer, Renewal, Sale

The conditional use permit issued by Carbon County to develop the leach field near the UP & L substation will expire the end of September 2007. Further development of this utility by the Town will be postponed until the first quarter of 2008.

The Permittee has installed a new "topsoil storage" sign on the South Fork and Middle Fork piles.

4.d Hydrologic Balance: Water Monitoring

Mr. Reynolds indicated that he has recently been conducting field water monitoring for the third quarter of 2007.

7. Coal Mine Waste, Refuse Piles, Impoundments

The Permittee has backfilled the exploration pits which were dug on Refuse Pile #1.

8. Noncoal Waste

The Permittee is currently negotiating with two scrap steel contractors who have shown an interest in the old machinery about the site.
