Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

The Permittee notified the Division on December 17, 2007 that the third quarter of 2007 surface and ground water monitoring information for the Hiawatha Mine Complex permit area was in the DOGM electronic data base pipeline acceptable for uploading.

There is no activity occurring at the site. The road to Middle Fork had been plowed, but only a two wheel track existed to South Fork. The snow depths have compacted to approximately a five inch depth.

There are no pending compliance actions for this site.

The Permittee intends to apply for a Phase I bond release for the demolition and backfilling activities associated with the reclamation activities associated with slurry ponds #4 and #5, refuse pile #2, and some facilities demolition. Mr. Wayne Western is co-ordinating this activity for the Division.

8. Noncoal Waste

Mr. Reynolds reported that a scrapper, (A-1 Fabrication, Salt Lake City, Utah) will start removing derelict mining machinery, transformers and drums containing used lubricants from the disconnected electrical tipple substation, the truck shop below the South fork / Middle Fork junction, and the maintenance shop south of slurry pond #1 after January 1, 2008.
