Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

Access to this site was not possible due to deep snow and drifted areas. The drift across the railroad crossing was fifteen inches in depth. None of the facilities associated with this site could be accessed by vehicle. The Permittee is current relative to the required electronic quarterly surface and ground water monitoring information submittals for the Hiawatha Mine Complex permit area. The Special Permit Condition included as Attachment "A" of the current State permit is being met. Precipitation monitoring at the Bear Canyon Mine indicated that snow was received fourteen days in January. The access to the site facilities is snow blocked. Plowing is not occurring.
