2. Signs and Markers

The ID signs contained the necessary information and were located at the points of entrance from the public road to the permit area.

4.a Hydrologic Balance: Diversions

The diversions mentioned in the previous inspection in middle fork and around the lower perimeter of the refuse pile have been cleaned to meet the designed criteria in the approved mining and reclamation plan.

8. Noncoal Waste

Several items of noncoal waste were observed around the lower perimeter of the refuse pile (cardboard, tires, bottles). These items need to be gathered up and disposed of properly.
