2. Signs and Markers

The identification signs are next to the roads to the mine site.

3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

The diversions were spot-checked and would function during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Some of the sediment ponds did contain water. These ponds would not discharge in the near future unless there were major rainstorms. No hazardous conditions were noticed during the inspection.

4.e Hydrologic Balance: Effluent Limitations

There has been no discharge from the sediment ponds for the second quarter of 2009.

8. Noncoal Waste

There are non-coal waste material throughout the property.

10. Slides and Other Damage

No slides were noticed during the inspection.

13. Revegetation

Slurry #4 and part of #5 are revegetated.

16.a Roads: Construction, Maintenance, Surfacing

Road drainage is still functioning as designed.
