2. Signs and Markers

I question the permittee about the phone number on the sign and no one answered or returned by phone call. He would look into the problem and take care of it.

3. Topsoil

The topsoil on Slurry #5 appeared to be stable and vegetation is growing on the reclaim portion of the pile.

4.a Hydrologic Balance: Diversions

Several diversions were inspected around slurry pond #5. They were functioning as designed. No water was within the diversions during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I walked around Slurry pond #5 and I did not see any hazardous conditions. The reclaim and non-reclaim sections of the pile appear to be stable.

8. Noncoal Waste

Some of the areas around the sub-station has old steel and non-coal waste materials.

13. Revegetation

I am not a vegetation person but in my opinion the grasses and plants are doing good on the reclaim portion of the slurry pile.

21. Bonding and Insurance

The insurance policy has but renewed. The policy number is GL 360-21-36 and will expire on Jan 1, 2010. The company affording coverage is AIG.
