2. Signs and Markers

The identification signs are next to the roads to the mine site.

4.a Hydrologic Balance: Diversions

The diversions were spot-checked and would function during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds contained little to no water. No hazardous conditions were noticed.

4.c Hydrologic Balance: Other Sediment Control Measures

The track spur and storage yard for timber was inspected. This area reports to a sediment pond. There is coal fines outside this area but is classified as pre-law.

7. Coal Mine Waste, Refuse Piles, Impoundments

The slurry ponds were not being mined for the last several months.

8. Noncoal Waste

The South and Middle Fork areas have been cleaned up of non-coal waste materials.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

15. Cessation of Operations

The permittee meets all the requirements of Temporary Cessation. There is no activity at the slurry ponds. The permittee needs to submit a letter requesting temporary cessation. I

No new support facilities were constructed.
