2. Signs and Markers

The identification signs are next to the roads to the mine site.

3. Topsoil

Topsoil piles were inspected with no signs of erosion.

4.a Hydrologic Balance: Diversions

The diversions were spot-checked and would function during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment ponds contained little to no water. It is unlikely that they will discharge in the near future. No hazardous conditions were noticed during the inspection.

7. Coal Mine Waste, Refuse Piles, Impoundments

The site is inactive. The slurry piles have not been mined for several months.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

12. Backfilling And Grading

No reclamation is taking place at Hiawatha.

15. Cessation of Operations

The company has submitted a letter to the Division that it's Hiawatha operation is in Temporary in Cessation.

16.a Roads: Construction, Maintenance, Surfacing

The road to Middle Fork is falling apart. The asphalt is breaking up.

18. Support Facilities, Utility Installations

No new support facilities were constructed.
