13. Revegetation

New reference area locations were selected for the slurry ponds and the north fork of Miller canyon reclaimed areas. The previous sites were either decadent sage brush or had been burned by the Sealy fire. Since these the postmining landuse for these areas is wildlife and grazing a woody species density will need to be determined in consultation with DWR. Pertinent regulations include R645-301-356.231

21. Bonding and Insurance

The permittee is currently in year 9 of their liability period on several reclaimed areas for the Hiawatha mine and plans on preparing a phase 3 bond release application next year if the vegetation success is adequate. The regulations currently require 2 years of back to back sampling data.
