2. Signs and Markers

The mine identification signs are in place along side of the county roads used to access the mining permit area. The signs have been recently updated and contain current information in a format acceptable to the Division.

4.a Hydrologic Balance: Diversions

Diversions are not visible do to snow covering from recent storm events.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is covered in a blanket of snow. The area was accessible since the refuse pile is located at a lower elevation than the portal areas. The pile appears stable. No visible hazards existed. Some clean up work had been accomplished since the prior inspection around the perimeter of the pile.
