2. Signs and Markers

There are two mine identification signs posted at entrances into the mining permit area from a public access. Both of these signs are made out of plate steel that has been laser cut with the required information in them. These signs were inspected as part of this partial inspection and were found to be in compliance with the Utah R645 Coal Rules.

4.a Hydrologic Balance: Diversions

The undisturbed diversion (CMP) in middle fork canyon has been cleaned and maintained. A section of the culvert was dug up and replaced as part of the maintenance process. The culvert was almost completely cleaned this summer when another storm hit and completely filled the culvert again. The problem arises from the previous fires and the increased sediment load resultant from that fire. A trash rack has been installed over the culvert inlet as well.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond in middle fork canyon is still filled over capacity as a result of the increased sediment load produced from every storm event since the forest fires. The pond has had several attempts to clean out the material, which is filled back in by the newest storm. Currently a small amount of water remains in the pond. A conscious effort now needs to be made to clean the pond before fall/winter sets in to bring the pond back into compliance. No enforcement action has been taken due to the fact that circumstances have been out of the control of the operator and the efforts that have been made to restore the sediment pond back to the original design.
