2. Signs and Markers

The mine identification signs are located along side of carbon county roads that lead into the mining permit area. The signs contain the address, phone number, name and mining permit number as required in the Utah R645 Coal Rules. The signs are in compliance with the Coal Rules.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond located in middle fork was being cleaned during the partial inspection today. The pond has been severely impacted from storm events following the foreset fire, which has caused additional sediment contribution to the pond. Pond sediment sluffage during the cleaning took out the decant pipe. This pipe will need to be replaced.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile is stable. No visible hazards were observed.
