2. Signs and Markers

Identification signs are in place at permit boundary and are compliant.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond cleaning in middle fork is still taking place. Active work was occurring during the partial inspection. The material is currently being excavated out of the pond with a track hoe. The material is then being hauled from the pond to a pad area by a rubber wheeled loader. A second loader has been brought to the site so that two loaders can be used to haul the material. As stated in the previous inspection report the CMP spill way was damaged by sloughing material. A new stand pipe is on site ready to be installed when enough material is excavated near the Location of the stand pipe to prevent future damage. Pictures of the pond cleaning were taken and are attached to the PDF version of this inspection report.

7. Coal Mine Waste, Refuse Piles, Impoundments

Refuse pile is stable.

8. Noncoal Waste

Noncoal waste items have been gathered from various locations and have been stock piled prior to being hauled off.
