2. Signs and Markers

There are two mine identification signs located on the main county road that are located on either side of the main entrance into the mine area. The signs contain all of the required information. The signs are laser cut into steel plate for durability.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond in middle fork still needs additional cleaning. Work has begun and needs to be resumed when the ground freezes more.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable during the inspection. No visible hazards were observed.
