2. Signs and Markers

There are two main mine identification signs. These signs are posted along side of the county road. One sign is on the North side of the Permit area and the other sign is on the South side of the permit area. Both signs are uniform and contain all of the required information. The name, address. Phone number and mining permit number are on the signs.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond in middle fork still needs to be cleaned. Access to the sediment pond from winter conditions has not occurred yet, but should be possible in the spring. The pond has filled with an overload of sediment several times as a result of the forest fire that occurred several years ago.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards were observed.
