## **2. Signs and Markers**

Mine identification signs are in place at points of access from a public road into the mining permit area.

## **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The sediment pond located in middle fork is in the process of being cleaned. The same conditions exist with high intensity storms that slow and/or halt the cleaning process. This area is located below and adjacent to the burn area that now liberates additional soil contributions. Measures have been taken to reduce additional sediment contributions from the burn area.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile appears stable. No visible hazards were observed.

## **22. Other**

Removal of thistle in the permit area is actively taking place. Plants are being cut and sacked, In addition the area is being treated with chemicals to retard the reoccurrence.
