2. Signs and Markers

The county access road used to access the mine site was plowed and open. The two mine identification signs associated with this mine are posted along side of this county access road at different points of entrance into the mining permit area. Both signs are plate metal that have the information laser cut into the sign. The signs contained the name, address, phone number and mining permit number as required by law. The signs are in compliance with the law.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Slurry Cell #5 was observed as part of the partial inspection. The pond was breached many years ago in accordance with MSHA request to de-commission the slurry pond. The entire pond area is snow covered by a large amount of snow. Many other portions of the mine site are currently inaccessible due to the volume of snow accumulations.
