2. Signs and Markers

The mine identification signs are located at two different access point into the mining permit area. These signs are constructed out of plate metal that has been laser cut with the required information. The signs shows the name, address, phone number and mining permit number of the operator.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Cleaning of the lower rail yard pond is taking place. The sediment pond in middle fork has completely filled with sediment through the winter and subsequent runoff. The current track hoe is not functioning properly. A new track hoe is being brought in to address the sediment pond cleaning and needed road work repairs

5. Explosives

No explosives are maintained or stored on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards were observed. MSHA conducted an inspection of the refuse pile a few days before the Division inspection and did not have any concerns.

16.a Roads: Construction, Maintenance, Surfacing

Roadways into Middle Fork and South Fork need maintenance on erosion cuts from diversions along side of the roadways.
