5. Stipulation R614-303-321.300(4): The permit renewal date of December 10, 1994 has been incorporated into page 11 for insertion into the MRP.


6. Stipulation R614-303-321.300(5): Pages with the date September 1, 1991 are enclosed for insertion in the MRP.
