1. PERMIT -

A) The quarterly pond inspection was taken on September 4, 1994 for third quarter. No hazardous conditions were reported.

B) The bonding agreement was signed by both parties on June 9, 1994 for the amount of \$3,266,999.

C) The insurance accord form was reviewed and the expiration is January 1, 1995.

D) The air quality permit was approved on October 28, 1994.

E) The NPDES permit was issued on July 1, 1994 and will expire on April 30, 1999.

2. SIGNS AND MARKERS -

The identification signs were located at gates to public access roads. The information meets the requirements of the R645 regulations. The signs will need to be changed if this property is sold and approved by the DOGM.

4b. SEDIMENT PONDS AND IMPOUNDMENTS -

The ponds were inspected with no discharging of water occurring. Some ponds did contain a small amount of water, but were far from discharging out of the ponds.

d. WATER MONITORING -

The water monitoring report was reviewed with the third quarter samples being taken twelve days after the quarter had ended. A Notice of Violation was written (94-39-2-1, violation 1 of 1). The abatement was to do two samples for fourth quarter.

7. **SLURRY PONDS -**

The weekly refuse pile inspection reports were inspected during December's complete inspection. It was noticed that the third week inspection was not documented nor could be confirmed at that time, therefore, a Notice of Violation was written (94-39-2-1 violation 2 of 2). The operator abated the violation the same day by inspecting the slurry ponds.
