The phone number of the identification sign at the main gate has started to fade. The numbers will soon need to be redefined.

4B. SEDIMENT PONDS -

The sediment ponds which were inspected contained little or no water. It is highly unlikely that the ponds will discharge this summer. There were no signs of hazardous conditions existing to the sediment ponds.


4C. OTHER SEDIMENT CONTROL MEASURES -

The Wellington site uses straw bales and silt fences as its alternate sediment control measures. Several locations were inspected with no notice of violation occurring. The installation is by the requirements of the Mining and Reclamation Plan.
