**2. SIGNS AND MARKERS -**

The identification signs were inspected and comply with the R645 regulations. Signs are located at entrances to the property from the public highway.

**4A. DIVERSIONS -**

The diversions were spot-checked and possibly some additional work still needs to be completed on the Siaperas ditch. Additional study by the inspector is required for compliance.

**4B. SEDIMENT PONDS AND IMPOUNDMENT -**

The sediment ponds were spot-checked with some containing water. There were no signs of hazardous conditions to these ponds.
