Identification signs are at the gates entering the property from public roads.

**3. Topsoil**

Sediment ponds were inspected with no hazardous conditions noticed during the inspection.

Silt fences were fixed by the permittee prior to the inspection.

**4.d Hydrologic Balance: Water Monitoring**

Water monitoring was taken for the third quarter. Samples are at the lab.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

Refuse piles and slurry ponds were inspected with no hazardous conditions noticed during the inspection.

**8. Noncoal Waste**

Small amount of non-coal waste by gate entering the slurry ponds.
