1. Permits, Change, Transfer, Renewal, Sale

The permittee has received a UPDES Permit #UTG040010. This permit will expire on April 30, 2013. AIR Quality Permit is DAQE-92. The DOGM Permit will expire on December 9, 2014.

2. Signs and Markers

Identification signs are posted at the gates to the property. Information meets the requirements of the R645 Coal Rules.

3. Topsoil

There were no signs of wind or water erosion to the topsoil piles.

4.a Hydrologic Balance: Diversions

The diversions were spot-checked and would function during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The permittee conducted annual sediment pond inspections in the first quarter of 2010 on January 20, 2010. I inspected the sediment ponds and did not see any hazardous conditions. The MSHA monthly inspection were taken and no hazardous condition reported.

4.c Hydrologic Balance: Other Sediment Control Measures

The permittee has installed straw bales and replaced or fix silt fences throughout the property.

4.d Hydrologic Balance: Water Monitoring

Water monitoring was taken for the first quarter and submitted 4th quarter water data to the Division.

4.e Hydrologic Balance: Effluent Limitations

There was no discharge for the third and first quarter of 2010.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected on March 18, 2010. The document is P.E. certified. No hazardous conditions were reported.

8. Noncoal Waste

The site was clear of non-coal waste material.

No slides or other damage was noticed during the inspection.
