1. Permits, Change, Transfer, Renewal, Sale

The permittee has an amendment in to the Division to use coarse refuse for train track ballast. This amendment is under review.

2. Signs and Markers

The permittee installed new identifications from roads leading to public access. The information contains within the signs meet the R645 Coal Rules. They have also installed new MSHA signs.

3. Topsoil

The permittee is using substitute topsoil for train track grade. The action of using substitute topsoil was approved by the Division because there is enough substitute soil on the property. Topsoil pile was stable with no signs of water or wind erosion.

4.a Hydrologic Balance: Diversions

The diversions and culverts were recently clean throughout the property. No water was flowing within these diversions and culverts at the time of the inspections. The diversions would function as design during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds and the Clear water pond were inspected. The ponds contained little to no water. It is unlikely that these ponds will discharge. The embankments were inspected and appear to be stable. No hazardous conditions were noticed during the inspection.

4.c Hydrologic Balance: Other Sediment Control Measures

The permittee installed new silt fences and straw bales throughout the property. Many to the locations do not require sediment control. Some sediment control is used for ancillary roads that do not require sediment control.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse piles and slurry ponds were stable. No hazardous conditions were noticed during the inspection.

8. Noncoal Waste

The permittee is continuing to clean non-coal waste materials from the Westside of the permit area.

16.b Roads: Drainage Controls

Road drainage was functioning as designed.
