1. Permits, Change, Transfer, Renewal, Sale

The permittee will be submitting an amendment to remove a portion of the permit area out of SMACRA. These areas are undisturbed by mining and are used by the Trans loading of oil.

2. Signs and Markers

The permittee installed new identifications from roads leading to public access. The information contains within the signs meet the R645 Coal Rules. They have also installed new MSHA signs.

3. Topsoil

The topsoil piles were inspected with no signs of wind or water erosion. The topsoil piles were stable.

4.a Hydrologic Balance: Diversions

The diversions and culverts were recently clean throughout the property. No water was flowing within these diversions and culverts at the time of the inspections. The diversions would function as design during a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Most of the sediment ponds were dry. No hazardous conditions were noticed. The embankments were stable. The sediment ponds are not likely to discharge in the near future.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse piles and slurry ponds were stable. I did not see any hazardous conditions. Maybe in the near future there will be mining of this material.

8. Noncoal Waste

The permittee continues to clean non-coal waste material. The site has never look so good.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

15. Cessation of Operations

There is no mining activity, but, it is rumor that mining could happen in the near future. Most likely the slurry and course refuse pile on the eastside will be mine.
