## **2. Signs and Markers**

The mine identification signs are located at all points of access from the public into the mining permit area. The signs contained the appropriate information.

The slurry cells, clear water pond and refuse piles are all marked with identification signs that show their MSHA ID numbers.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The Clear Water Pond (MSHA Pond) had a minimal amount of residual water from storm events.

### **4.c Hydrologic Balance: Other Sediment Control Measures**

A large portion of the alternate sediment control measures have been recently maintained/replaced in the last month. The site is approved to use silt fences, straw bales and wattles.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse piles appeared stable. No visible hazards were observed.

## **8. Noncoal Waste**

The mine site was free of noncoal waste items.

### **16.a Roads: Construction, Maintenance, Surfacing**

Roads throughout the mine site are well maintained.
